- The abstract should be in the following format: Times New Roman, Font Size 12 & Line spacing 1.5, Justified 1-inch margins on all the four sides, Paper size: A4.
- All submission are to be made in MS Word format only.
- The abstract must clearly identify a research problem to be discussed by the author in the full paper, and the particular theme of the conference associated with the paper.
- Please name your abstract file as follows: Full Name\_abstract e.g. if author's name is Aditya Ranjan, then the file name should be Aditya Ranjan\_abstract.
- Selected abstracts shall be intimated separately along with a link for full paper submissions
- Co-authorship is allowed for up to two authors
