- **1. Courses** The Test is applicable for applicants interested in joining the 5 Year Integrated Programmes of the School of Law –
- BA. LL.B (Hons.)
- BBA. LL.B (Hons.)
- B.Sc. LL.B (Hons.) Specialisations in Biotechnology / Cyber Security / Forensics

- **2. Eligibility**—As per the standards set by the Bar Council of India, any candidate who has secured a minimum of 45 percent of the total marks(for general category students), or has secured a minimum of 40 percentof the total marks (for SC and ST category students), in his / her +2 education, is eligible to apply for the test.

Candidates presently pursuing +2 education can also apply for the test.

However, all candidates must submit the +2 Pass Certificate and Mark Sheet latest by the time of commencement of the Courses.

The maximum age for admission will be as per the conditions laid by the Bar Council of India.



- 3. Test Fees —Fees will not be charged in the Test. Participation is free of cost.
- **4. Test Dates** The Test will be conducted simultaneously across all Centers stated below on **Sunday, January 12, 2025.**

- 6. **Test Pattern** The test will be an online, multiple—choice question—based exam with 120 questions to be answered in 150 minutes. Correct answer will be awarded +3 points and wrong answer will lead to a deduction of -1 point.
- **7. Test Components and Marks Allocation** The Test shall comprise questions from the following components with their respective allocated marks:

8. Registration For the Test -

Applicants interested in appearing for the test can access the registration link from the School of Law website – https://law.kiit.ac.in

The last date for registration is **8 January**, **2025**.

9. Test Procedure And Requirements –

- a) The Test will be an "Objective-type" computer-based test where the questions would be shown and answers would be marked on a desktop computer provided for this purpose at the Test Centre.
- b) Candidates must be conversant with the basics of computer application, such as using the mouse, keyboard and other basic computing tasks.
- c) Candidates have to bring their printed admit cards to the Test Centre and reach the Centre at-least 30 minutes before the commencement of the Test so that they can familiarize themselves with the rules and instructions for taking the Test.

- d) No candidate will be allowed to enter the Test Centre once the Test has commenced.
- e) A seat will be allocated at the Test Centre indicating the application number of the candidate, which such candidate should find out and occupy before commencement of the Test. The candidature of a candidate shall be immediately cancelled if he / she is found to have changed the allocated hall or seat on their own and without prior permission of the competent authority.
- f) No candidate can leave his / her seat or examination hall without the permission of the Centre Superintendent / Invigilator, till the completion of the Test.
- g) No food, tea, coffee etc. is permitted inside the examination hall.
- h) Phones, pagers, cameras, laptops, iPad, smart watches, calculators or any other such electronic, electro-mechanic or electrical devices are **not allowed** inside the examination hall.
- i) The invigilator shall announce the commencement and completion of the Test. Candidates should leave their respective seats only on hearing the announcement of completion of the Test.
- j) The questions will be set in English and not in any other language.
- k)Candidates shall maintain silence in the examination hall. Any conversation or gesticulation or disturbance in the examination hall shall be deemed as misconduct. If any candidate is found using unfair means or impersonating, his / her candidature shall be cancelled and he / she will be debarred from the Test.
- I) All the questions will be of objective type and three marks will be awarded for each correct answer. There is one negative mark for any wrong answer.
- m) The Test Centres are mentioned earlier in this document. For any unforeseeable reason if the Test could not be conducted at any selected Centre, then the candidate will be asked to appear for the Test in the nearest available Centre.
- n) There shall be no retest for candidates unable to appear for the Test for any reason.
- O) Candidates can download the admit card from the School of Law website https://law.kiit.ac.in from 10 January, 2025. The printed admit card should be carried by the candidate to the Test Centre and should not be altered, mutilated or defaced.

- Candidates whose particulars do not appear on the website or are facing any issues can contact the Admissions Section of the School of Law at the email address appearing at the end of this document.
- **10. Results** The result of **KIITEE Law 2025** will be declared on the School of Law website law.kiit.ac.in **on January 20, 2025.**

Candidates must preserve the result card till completion of the admission process.

- **11.Cancellation of Admission** The admission of a candidate is liable to be cancelled at any point of time if -
- a) any information provided by the candidate in the application form is found to be incorrect or misleading;
- b) the candidate fails to submit the final Marksheet and Pass Certificate at the time of commencement of the Course;
- c) the terms and conditions of the admission offer letter are not fulfilled;
- **12. Legal Jurisdiction** All disputes pertaining to the conduct of **KIITEE Law 2025** shall fall within the jurisdiction of the appropriate Court within Bhubaneswar, Odisha, India only.
